*Each CIT will be assigned a group or specialty area of instruction for the duration of their enrollment. We will provide an excellent learning environment, with proper supervision. The CIT's will have some free time in the afternoon schedule for swimming, basketball, etc. Each CIT will be evaluated by their cooperating Senior Counselor, CIT Coordinator and camp administrator. We will meet regularly with each CIT to inform them of their performance and make suggestions if and when necessary.*
